CHIEF FOUNTAIN: I just want to thank everyone for coming out tonight and thank the officers in the back who do the work for us every day in and out Mantas has now joined that elite group of people. And the new supervisor Jared here and of course Lenny new Captain and Pete thank you for all your family coming out. Our Honor Guard and the Pipe and Drum band they were excellent because they give us a little extra St. Patrick's Day stuff for earlier. They like to give us a big build up which is nice. And of course our retired guys in the back who showed up thank you all for coming out so much it means a lot to everybody here that's still here and as Mantas was taking his oath I was like boy it seems just like yesterday but I looked a lot different, right Bob? Thank you Mayor, governing body members and of course Tara without you we couldn't have done this, thank you so much.

MAYOR COHEN: Thank you very much. Congratulations to everyone and we're going to take a five-minute break so that everybody who wants to leave can good luck to everyone. We are back and we have two proclamations this evening. The first proclamation is for Congenital Heart Defect Awareness Month unfortunately we were supposed to read this in February and then we had our storm. And it's especially important to us because of Committeeman Uniglicht. Committeeman Uniglicht will accept the proclamation and you'll say a few words? Okay great. Whereas, Congenital Heart Defects CHD occurs when a baby's heart fails to perform properly during early pregnancy, CHD the chronic disorder requiring lifelong on going care while long term outcomes are unknown and the risk of additional problems is high. And Whereas, Congenital Heart Defects require lifelong medical care, multiple surgeries and preventive measures to maintain a working heart and healthy body. The mortality rates from CHD has dropped nearly 40% in the past 18 years proving that awareness of CHD is essential in preventing the death of thousands each year. Whereas approximately 40,000 babies or about one in every 125 are born each year in the United States with a Congenital Heart Defect; now with improvements in research and medical care there's now an estimated 2 million adults in the United States alone living and thriving with CHD. Whereas because there's still a lack of awareness and screening for CHD there is still too many cases of sudden cardiac death in young athletes and others that were never screened for or diagnosed with CHD. Whereas, early detection is critical and a successful treatment of CHDs many CHD may be treated with surgery, medicine and implanted devices if detected early enough; and whereas, a routine ultra-sound and prenatal eco-cardiogram performed by a pediatric cardiologist during pregnancy are the most effective methods for early detection of the CHD; whereas, the Township of Manalapan Commends all those involved with raising awareness about Congenital Heart Defects and extends best wishes for a memorable observance of a Congenital Heart Defect Awareness Month. Now, therefore I, Mayor Susan Cohen, the Township of Manalapan in recognition of the Awareness of Congenital Heart Defect proclaim February to be the Congenital Heart Defect Awareness Month in the Township of Manalapan and urge all residents to show their support for CHD and all those who raise awareness about Congenital Heart Defects. We commend Township Committeeman Kevin Uniglicht for his unrelenting work with the CHD Awareness and I'm proud to have him represent Manalapan as he was in Washington D.C. and continues to raise awareness; In witness whereof I here to set my hand and cause the seal of the Township of Manalapan to be affixed on the 20th day of February in the year 2019.

MR. UNIGLICHT: Thank you Mayor this means a lot to me personally, I appreciate the Mayor and the Township Committee everybody getting this proclamation on. I was born with a Congenital Heart Defect, thankfully, I was one of the few that made if I was born instead of the 70's probably maybe in the 60's or earlier, I probably wouldn't be here today that's thanks to people back then investing

some time and resources and money the shocking number for me is that it is one in a hundred that are born with some sort of defect. It's kind of like the baby boomer effect right now all the kids are becoming adults but there's just not enough doctors out there to take of everybody. So, Mayor thank you and I appreciate it very much.

MAYOR COHEN: Thank you Kevin. And our second proclamation is for Colorectal Cancer Awareness Month for March. Whereas, March is recognized national as Colorectal Cancer Awareness Month in observance that provides a special opportunity to offer education about Colorectal Cancer causes, screenings and the importance of early detection. And whereas, the Colorectal Cancer is the second most common cause of cancer deaths for men and women in the United States and in New Jersey. And whereas one in twenty men and one in twenty-four women will be diagnosed with Colorectal Cancer in their life time. And whereas there are more than one million survivors of Colorectal Cancer in the United States and whereas the New Jersey Cancer education and early detection program NJCEED provides free Colorectal Cancer tests to uninsured and under insured men and women. And whereas, if the majority of people in the United States age 50 or older were screened regularly for Colorectal Cancer half of all the cases would be prevented entirely and whereas, Colorectal Cancer is preventable, treatable and beatable in most cases. And whereas, the regional chronic disease coalition as joined the National Colon Cancer Alliance by encouraging others to wear blue in March as a reminder to talk to your doctor about getting screened as the vast majority of cancer deaths can be prevented through early detection. And now therefore be it proclaimed that I, Susan Cohen, Mayor of Manalapan Township do hereby claim March, 2019 as Colorectal Cancer Awareness Month and urge all residents to help raise awareness of this dangerous disease. In witness whereof I have hereto set my hand and seal and cause the Township of Manalapan to be fixed on this 13th day of March in the year 2019. And if you notice that we're all wearing blue for this and also in honor of police officers. We will continue now with our Township Committee Reports Mayor Musich.

MRS. MUSICH: Thank you Mayor. First I' like to thank the Honor Guard and the Pipe and Drum for stepping up our game tonight they'll be hard to beat next month when have nobody so but thank you so much for showing up and doing that. I'd also like to thank our newly retired Captain Tommy Barstow for his many years of service and for always being attentive to our needs, he was great and we're going to really miss him! Congratulations also to our Police Department on some very well deserved promotions tonight, namely Captain Lenny Maltese, Lieutenant Peter Chalfin and Sergeant Jared Aronson. And also we'd like to --- I'm happy to welcome Patrolman Manny Stanionis. I'd like to thank the entire Police Department under Chief Michael Fountain for all that they do for the community. So, many times they've gone over and above what's expected of them and we appreciate it so much. In recreation: the spring youth track program is currently accepting applications the program will begin on March 30th and it's open to grades K-12. The spring sports squirts class is also accepting registration this is opened to residents ages 2-7 and will be held on Saturday mornings beginning April 27th. Adult Hula fitness starts it's next season on March 25th and will be held on Mondays at 7:00 PM. Our new 'Tone Up Tuesdays' fitness class will begin at 7:30 PM on March 26th and is opened to ages 15 and older. The annual Easter Egg Hunt is scheduled for Saturday, April 13th. Registration is still being accepted for the 2019 summer camp and travel camp programs, registrants must be residents of Manalapan to be eligible. Seniors: reservations are still being accepted for two bus trips that are coming up; one will be on Wednesday, April 17th to the Museum of the American Revolution in Philadelphia at a cost of \$39.00 dollars. And the other one is a trip on Wednesday, May 15th to the Media Theatre in Pennsylvania to see a live production of 'Saturday Night Fever' at a cost of \$50.00 dollars. On Friday, March 22nd the Senior Center will be showing the movie 'Green Book' at 10:00 AM. Cable: Cable TV has been active in taping meetings, Planning Board, Zoning Board, Township Meetings, community events like Black History Month at the Library and the Community Alliance Open House. Their volunteers do all the work and they could use some help and if anyone is interested in joining the Cable Committee they can check mtnj.org for a volunteer application and submit it and you can join them in this community effort. Historical: the display at outside the courtroom over here was redone with historical items that are of interest in Manalapan and some artifacts. It's a continuing effort to update and make sure that --- the historical interest is promoted and on display in Manalapan. On March 23rd from 1:00 to 4:00 Covenhoven House on 150 West Main Street there's going to be an open hearth tour from 12:00 to 4:00. It's an exhibit to show cooking from the Revolutionary War period, it's a free tour, it's open to the public it will be children activities and for adults. And if anyone is interested it is right off of Route 9 on Main Street in Freehold. Environment: The Environmental Commission has reviewed some site plans for recommendations for that are submissions to the Planning Board and Zoning Board. The chairwoman and MEC member Pam Eisenman met last year with the --- in Colts Neck High School with the ROTC and they set up a Partnership and this year the chairwoman informed them that the Eco-Patio in the Rec Center is getting a --- needs a little cleanup with weeds and so they volunteered to help clean up the Eco-patio. The cleanup will be March 23rd from 10:00 to 12:00 and if anyone is interested in assisting they're welcome to join again it's at the Rec Center on Saturday March 23rd and that's my report thank you Mayor.

All our first responders I'm pretty confident that if I didn't have the congenital heart defect that I was born with I might be right over there with them so I have a special place in my heart for law enforcement and what have you. So congratulations to all of you and keep up the good work in our community. Shade Tree meet last night I just want to mention that Saturday, April 6th time and place to be determined they will be handing out the seedlings for trees. You can plant them and watch them grow and maybe have a hundred-foot tree one day. So come on out on April 6th and keep your eyes out for where it's going to be. Board of Ed met last night and will also be meeting next Tuesday, they're beginning their budget discussions so encourage residents it is a separate entity from this township but it is your tax dollars at work. So, I encourage you to go out to their meetings on Tuesday nights they are posted and come out and you know hear what's coming up with the budget. Economic Development there is a ribbon cutting currently scheduled for State Farm Insurance at 9:30 they're on Gordon's Corner. I want to congratulate newly appointed member Lisa Jackson and Mayor if we could go out of order just slightly I see we have an appointee in the courtroom here for the Economic Development Council if we could appoint him I know he is here with his family I think and we could let him go home.

MRS. LOVRICH: Does he want to call his family back in the room and then somebody can make a motion for that resolution. Do you want to call him back in?

MAYOR COHEN: Okay let's wait till he comes back in. Okay so we're going to go a little bit out this would've been my fourth resolution appointing a member to the Economic Development Council a motion has been made I need a second.

Steven Baker for those of you old enough to remember Super Bowl 25, a touch down maker for the New York Giants will be there. He is the high tec kid he has the airplanes, drones and the likes of that so again come on out it's a great affair. For the Grandfathers and Grandmothers bring the kids along show them the history of the past when the trains ruled America. So, again that'll be Sunday the 24th 9:00 to 3:00 put on by our Veterans. Also from our Veterans Affairs Committee there is a \$500.00-dollar scholarship to Manalapan Seniors and what you need to do is 'What has a Veteran Done for Me'. It's always been where you can write an essay and that is still allowed but now also being in more with the times you can do a story, you can do a poem, you can do a video. But what we're looking for is for the Manalapan Seniors put something together what a Veteran has meant in your life, maybe a grandfather or father or brother or sister, somebody who is serving right now. And again to our Police Department you going to see in our next two meetings we're going to be talking about budgets as Mr. Ungilicht brought up about the school. Unfortunately, we should never use public safety and budgets together yet that's what the five elected officials here do we figure out how to pay for everything. So, again to Captain Barstow after 25 plus years here at the Manalapan Police Department, thank you for your service you certainly earned the retirement enjoy it. And again to Captain Maltese what you notice is when a high ranking official leaves the newest man does not come to the top obviously right? So the lieutenant becomes the captain the sergeant becomes the lieutenant the patrolman becomes the sergeant and the likes of that. So, again a special thanks to Captain Maltese to Lieutenant Chalfin, to Sergeant Aronson and see if I can get this right to Patrolman Stanionis and I practiced that. Stanionis right --- Stanionis I knew I got it. I have 30 years to practice by the time the man retires so I will get down here over the next couple of weeks. But again we welcome him aboard. Tonight you saw that we had our Explorers in the room so again you can see the depth to our Police Department it's one of those we hope we never need them but when times are bad the Police Departments are the ones that we rely on. So, again led by Chief Fountain, thank you for everything you do to all of the men and women of Manalapan Police Department and that'll conclude by report thank you.

MAYOR COHEN: Thank you very much tonight our moment of silence was for Chief Richard T. O'Brien, he was a life member and former chief of the Gordon's Corner Fire Company in Manalapan. And the former Commissioner of Manalapan Township Fire District number one. We send our condolences to his family

and thank them for his service to our residents. As we all mentioned congratulations to Captain Maltese, Lieutenant Chalfin, Sergeant Aronson and Patrolman Stanionis, I also can't pronounce it. Thank you to all of Manalapan's finest for keeping us safe. I'd like to commend Alan Spector and our Department of Public Works for their hard work keeping the roads clean during all our past storms. In February we said goodbye to Irene DiMiceli who worked for us for 25 years and was the Mayor and the Township Committee's Administrator coordinating Secretary. We thank Irene and wish you a happy and healthy retirement. Some messages from our Health Officer the Community Alliance is holding a video contest for all Manalapan residents of Manalapan High School or from any town as long as you attend Manalapan High School. The theme of the contest is "Substance Abuse, Prevention and Persuasion" students may enter a video 90 seconds or less communicating a message that informs, educates or in principal dissuades fellow youth from using drugs or alcohol or vaping except drugs, alcohol and vaping may not be in the video. Information is posted on the Township website mtnj.org and on the Project Zero website and you can call our Health Department for any information. The 2019 photo contest theme is "A Moment in the Life of Manalapan" a theme that allows for a lot of opportunity for capturing activities, events, people, landscape or anything that your imagination takes in a town that makes Manalapan a great place to live. MR. WINCKOWSKI: Yes, Mayor thank you there's one item on the agenda that's for the Release of the Performance Bonds for Atlantic Aerials it's a commercial site on Route 33. They have a small bond posted for some street repairs that are associated with their site plan development. The work has been satisfactory completed so we are recommending release of the performance bond. I have a letter for the Clerk I believe for a resolution at the next meeting and the bond is approximately \$15,228.00 dollars we are recommending release. We are recommending also a waiver of the typically required two-year maintenance bond based on the minor nature of the improvements and they have been completed for quite some time. And the payment of any deficient escrow, but the escrow account should remain opened because they have some onset work that has to be completed. So I'll work that out with the Clerk and the Finance Office.

MAYOR COHEN: Thank you very much. Clerk Mrs. Preteroti.

CLERK:

MRS. PRETEROTI: Thank you Mayor I have two Resolutions to add to new business tonight. The first one will be appointing a Full-time Animal Control Officer Debralee Lang. And the second one will be appointing a Full-time Clerk-Typist for Health which is Samantha Scala.

And I have a Resolution required by our Joint Insurance Funds that we pass and that's a Resolution to Affirm Manalapan Civil Rights Policy with Respect to all our Officials, Appointees, Employees this is part of employee manual. This is training that we do every year annually our supervisors and staff and the governing body as well through the JIF. So this just resolution puts that policy in writing for the JIF that's all I have.

MR. McLAUGHLIN: We'll defer to the assistant township attorney.

MR. WINCOWKSI: Thank you Mayor this Ordinance just modifies the section removal of trees and shrubs to provide a new procedure for notifying a resident when a tree in front of the property has to be removed because it's of hazardous condition or concern. The Ordinance already requires residents to be responsible for the tree but this just improves the procedure to let them know it's has to come down and imposes a penalty subject to municipal court review if they don't.

MAYOR COHEN: Very good okay. I need a motion to set the public meeting for March 27, 2019.

Mr. McLaughlin would you like to give us?

MR. McLAUGHLIN: Certainly Mayor this Ordinance will amend our development regulations to allow to the reviewing agency of a plan whether a subdivision or a site plan it could be either the Planning Board or the Board of Adjustment. In appropriate cases, the board has the power and does on occasion waive certain improvements particularly curbs and gutters or sidewalks in appropriate situations. What this does is permit the boards to do that but conditioned upon the developer paying the cost of those improvements so they don't have to spend on site into a curbing --- sidewalk and curbing capital improvement fund. And that fund will be maintained by the town and can be used later on at the discretion of the Township Committee to install sidewalks in areas where they're needed; curbing or other traffic safety improvements like crosswalks that sort of thing where they are necessary throughout the town. So those funds will be devoted specifically for traffic safety and pedestrian safety uses.

MAYOR COHEN: Thank you very much. I need a motion to set that for April 10, 2019.

MR. McNABOE: Are you ready? I'll move that.
