**RESOLUTION OF MEMORIALIZATION ADOPTING THE MASTER PLAN
REEXAMINATION REPORT AND AMENDMENTS TO THE MASTER PLAN**

WHEREAS, N.J.S.A. 40:55D-28 empowers the Planning Board to prepare, and after public hearing, adopt and/or amend a Master Plan to guide the use of land within the municipality in a manner which protects public health and safety and promotes the general welfare; and

WHEREAS, N.J.S.A. 40:55D-89 authorizes the periodic reexamination of the Master Plan of Manalapan Township; and

WHEREAS, the Township Committee did authorize the Planning Board to perform the periodic reexamination of the Master Plan; and

WHEREAS, proper notice of the hearings concerning the revision and amendment of the Master Plan were given by the Planning Board according to the requirements of N.J.S.A 40:55D-13; and

WHEREAS, the Planning Board held public hearings on the Master Plan Reexamination Report and the Amendments of the Master Plan on the following dates: March 29, 2001, April 12, 2001, May 24, 2001, August 9, 2001, September 20, 2001, October 3, 2001, October 9, 2001, October 16, 2001, October 29, 2001 and November 29, 2001; and

WHEREAS, the Planning Board considered the Master Plan Reexamination Report dated September 7, 2001 prepared by Richard S. Cramer of Townplan Associates, the Master Plan Amendment 01-1, Farmland Preservation Plan Element, prepared September 7, 2001 by Mr. Cramer, and the Master Plan Amendment 01-2, Land Use Plan Element Conservation Areas, prepared September 7, 2001 prepared by Mr. Cramer; and

WHEREAS, the Planning Board makes the following findings of fact and conclusions of law:

1. The Planning Board is authorized by statute to adopt, amend and reexamine the Master Plan for Manalapan Township.
2. Proper notice was given of these hearings and the Planning Board has jurisdiction to proceed with the Master Plan amendment and Reexamination process.
3. The Planning Board's planning consultant, Richard S. Cramer of Town Plan Associates prepared Master Plan Amendment 01-1, Farmland Preservation Plan Element; Master Plan Amendment 01-2, Land Use Plan Element Conservation Areas and the Master Plan Re-Examination Report, all dated September 7, 2001.
4. At numerous public hearings, Mr. Cramer explained his Master Plan Re-examination Reports and the Master Plan Amendments to both the Planning Board and interested members of the public; Mr. Cramer was subjected to vigorous cross-examination by members of the public and attorneys representing landowners in Manalapan Township.
5. The current Master Plan does not adequately protect and conserve the natural resources within Manalapan Township.
6. More effective measures and programs are needed in Manalapan Township to preserve the remaining open spaces, farmland, historic areas, forest and woodlands, water resources and stream corridors.
7. In order to achieve these goals, there must be reductions in both the permitted intensity and density of development.
8. The Master Plan Reexamination Report, Master Plan Amendment 01-1, Farmland Preservation Plan Element and Master Plan Amendment 01-2 Land Use Plan Element

Conservation Areas, prepared September 7, 2001 by Mr. Cramer are consistent with these goals.

9. The current Master Plan Reexamination Report and Master Plan Amendments 01-2 and 01-2, dated September 7, 2001 contain revisions from Mr. Cramer's first draft of the Master Plan Reexamination Report and Master Plan Amendments dated March 16, 2001.

10. The Master Plan Reexamination Report and Master Plan Amendments 01-1 and 01-2 dated September 7, 2001 by Mr. Cramer are currently before the Board and supersede the original draft dated March 16, 2001.

11. The Planning Board has carefully considered the testimony of Manalapan residents, farmers, developers and the arguments put forth by their attorneys and expert witnesses in opposition to the Master Plan Reexamination Report and Master Plan Amendments.

12. After thorough and careful consideration of the arguments of those opposed to the Master Plan Reexamination Report and proposed Amendments, the Planning Board is not persuaded by those arguments against to the Master Plan Reexamination Report and Master Plan Amendments.

13. The Planning Board finds that the Master Plan Reexamination Report and Master Plan Amendments 01-1 and 01-2 dated September 7, 2001 prepared by Mr. Cramer guides the use of lands within Manalapan Township in a manner which protects public health and safety and promotes the general welfare.

14. The Planning Board finds the Master Plan Reexamination Reports and Master Plan Amendments 01-1 and 01-2 dated September 7, 2001 prepared by Mr. Cramer to be credible and persuasive and consistent with the goals of Manalapan Township.

NOW THEREFORE be is resolved that the Planning Board of Manalapan Township hereby adopts the Master Plan Reexamination Report of September 7, 2001, the Master Plan Amendment 01-1, Farmland Preservation Plan Element, dated September 7, 2001 and the Master Plan Amendment 01-2, Land Use Plan Element Conservation Areas, dated September 7, 2001, as an amendment to the Master Plan of Manalapan Township.

NOW THEREFORE be it further resolved by the Planning Board of Manalapan Township that the Resolution of Memorialization together with the Master Plan Reexamination Report of September 7, 2001, Master Plan Amendment 01-1 and 01-2, dated September 7, 2001 be served upon the Monmouth County Planning Board pursuant to the Requirements of N.J.S.A. 40:55D-13.

This Resolution memorializes an action taken at the regular meeting of the Manalapan Township Planning Board held on November 29, 2001 on a roll call vote that evening as follows:

INTRODUCTION

The New Jersey Municipal Land Use Law (40:55D-1 et seq.) provides for the inclusion of a Farmland Preservation Element in a municipal master plan. In accordance with the M.L.U.L. the element shall include:

- 1) An inventory of farm properties showing and a map illustrating significant areas of agricultural lands;
- 2) A statement showing that municipal ordinances support and promote agriculture as a business;
- 3) A plan for preserving as much farmland as possible in the short term by leveraging monies made available by P.L. 1999 180 (C.4:1C-43.1) through a variety of mechanisms including, but not limited to, utilizing option agreements, installment purchases and encouraging donations of permanent development easements.

STATEMENT OF TOWNSHIP PRINCIPLES, GOALS, OBJECTIVES, AND POLICIES FOR FARMLAND PRESERVATION

The Township, as set forth in this plan element, establishes the following goals, objectives, and policies for farmland preservation in Manalapan.

Statement of Principle

Farmlands are essential to the State's agricultural economy, to controlling urban sprawl, and to preserving the rural features of Manalapan Township. Township efforts are needed to preserve farmland in order to maintain the community's agricultural heritage, to promote the local farm economy, to support State and County efforts to preserve the agricultural economy of the region and control urban sprawl, and to conserve the community's historic rural landscapes and its scenic, cultural, and natural features.



Goal Statement

The goal of Manalapan Township is to maintain the rural features of the community and secure the environmental, economic, and social benefits derived from farmland in Manalapan Township. To achieve its goal, the Township, in conjunction with the County, the State and the private sector, will actively encourage, support, and assist participation by local farmers and landowners in the Township, County and State Farmland preservation programs in order to preserve as much farmland in the Township as possible in the short term.

FARMLAND PRESERVATION PLAN

Farming contributes to the economic base of the Township and is essential to the open rural landscape that characterizes many parts of the community. In conjunction with the State Legislature's enactment of the Garden State Preservation Trust Act to preserve 1,000,000 acres of farmland and open space in New Jersey, Manalapan Township has taken the following measures:

- 1) Adopted a new open space, recreation, and conservation element for the Township Master Plan. The Township open space plan has been approved by the State for funding to implement the plan under the Green Acres Planning Incentive Program.
- 2) Approved a local levy for open space and farmland preservation.
- 3) Committed Township funding to support the County Agriculture Development Board acquisition of development rights to preserve Manalapan's farms.
- 4) Appointed a Township liaison to the County Agriculture Development Board.
- 5) Enacted ordinances to support the right-to-farm in Manalapan Township.
- 6) Zoned its farm areas for low densities.



- 7) Limited the sewer service area in an effort to discourage urban sprawl and the conversion of farms to non-agricultural uses.

Manalapan Township Farmland

A significant area of Manalapan Township (5,767 acres or 29.21% of the Township) continues to be qualified farmland and includes soils with good characteristics for agricultural uses. The lands within the Township with good agricultural capabilities are identified in the Township master plan open space, recreation, and conservation element. The agricultural areas that remain in Manalapan are located throughout the Township and include nurseries, field crops, and horse breeding. Many of the farms are also located in environmentally sensitive areas that include stream corridors and wetlands. Farmlands are critical to many species of wildlife and can provide habitat for threatened grassland bird species including the grasshopper sparrow and savannah sparrow which have been identified in Manalapan. Exhibit 1 shows the location of farmland assessed property throughout the Township.

Public Program to Preserve Farmland

To maintain its rural heritage and landscape, the Township needs to preserve as much farmland as possible. Residents of Manalapan Township are committed to supporting these preservation efforts. In 1999, Township voters approved a levy of two cents to establish an Open Space Trust Fund. The Township is committed to using its local fund to leverage additional State and County funding available through the Garden State Preservation Trust to preserve a maximum of the remaining open spaces, farms, and natural features in Manalapan.

The Garden State Preservation Trust Act became law in June 1999. The law responds to the overwhelming voter approval of a statewide open space referendum in November 1998. The referendum approved amending the New Jersey Constitution to establish a stable funding source dedicated to preserving the State's farmland, open spaces, and historic sites. The State goal is to add a million acres to the inventory of preserved open spaces, farmland, recreation areas, and historic sites in New Jersey. The State will



expend up to two billion dollars in the coming decade to achieve the goal. A significant portion of the revenue is earmarked to assist the open space and farmland preservation efforts of local governments such as Manalapan and to support the preservation efforts of the Monmouth County Agriculture Development Board.

The Garden State Farmland Preservation Trust, established pursuant to the Garden State Preservation Trust Act, is administered by the State Agriculture Development Committee of the New Jersey Department of Agriculture through the Monmouth County Agriculture Development Board. The County Board administers a farmland preservation program that expends State, County, and municipal funds to preserve farms and farmland. All of Manalapan Township is within the Monmouth County Agricultural Development Area. Consequently and pursuant to the New Jersey Agricultural Retention and Development Act, the Township has been determined to encompass productive agricultural lands that are currently in production or have a strong potential for future production. Township farms are therefore eligible for farmland preservation funds from the County Agriculture Development Board and from the State. This program ensures the preservation of farms through public purchase of the development rights. The farm remains in private hands and farm operations continue. However, the land can no longer be developed for non-farm uses. A farmer or farmland owner voluntarily enters into an agreement with the County and the State to sell the development rights to the public. On average, the County pays for 20% to 40% of the cost and the State pays the balance. To support State and County efforts, the Township in the past has committed to fund up to 11% of the County's share of the preservation costs. The Township should consider increasing its level of financial support and, in cooperation with the Monmouth Agriculture Development Board, the Township should market the farmland preservation program to local farmers. Information, assistance, and support should be provided to farmers who are interested in making application for preservation funding.

Monmouth County Farmland Preservation Plan



In September 2000, the Monmouth County Planning Board and the Monmouth County Agriculture Development Committee approved the County Farmland Preservation Plan. Farmland preservation in Manalapan is essential to the realization of the County plan. The County has established objectives for the preservation of farmland in Manalapan Township over the course of the next ten years. With building, land values, and population on the upswing, the County farmland preservation program is at a critical juncture. The County recommends an aggressive course of action to preserve a significant amount of farmland. From 1954 to 1997, the County lost more than 80,000 acres of farmland. Despite this loss, the County ranks second in the number of farms, third in the market value of agricultural products sold, and seventh in farmland acreage in the State. Monmouth County is considered to be the foundation of the State equine industry and is prominent in nursery and greenhouse production. The direct benefits of agriculture to Monmouth County include food production, employment, and net cash return. Other benefits that contribute to the high quality of life enjoyed by County residents include scenic views that enhance the aesthetic value of communities, providing areas for groundwater recharge, and providing areas for wildlife habitat.

Expansion of the County Farmland Preservation Program into Manalapan - A key feature of the County plan is to expand the County farmland preservation program to smaller farms and into the central portion of the County. Historically, the focus of the County farmland preservation program was on the municipalities of Colts Neck, Howell, Millstone, and Upper Freehold. Nearly 94% of the farmland preserved to date has been in Upper Freehold. The County plan recommends moving aggressively to include municipalities in the central region, which includes Manalapan Township, which is under extraordinary development pressures. Since 1990, Township has lost 2.5 square miles of farm qualified land, a reduction of nearly 22%. To accelerate preservation, the County has reduced the minimum application size for its preservation program from 25 acres to 6 acres to enable farmers with properties less than 25 acres to participate. By reducing the minimum land area, more central Monmouth County farms, which tend to be smaller, can participate in the program. While the average size of farms in Monmouth County is 68 acres, the median size is only 13 acres, an indicator of the high number of small farms in the County.



County Plan and State Plan Farmland Preservation Objectives - The County plan establishes a goal of preserving 46,180 acres of farmland in twelve municipalities, including Manalapan, over the next ten years. The preservation of farms in Manalapan Township is essential to achieving the County objective. The County has set a ten-year goal of 5,360 acres of farmland in Manalapan with priority given to farmland in State Planning Area 4B (Rural/Environmentally Sensitive) and State Planning Area 3 (Fringe). Based on farmland assessment, there are 5,767 acres of farmland remaining in the Township in all planning areas. Given existing development pressures, in order to approach the County goal, the Township will need to preserve farmland in all the designated State Planning areas of the Township, including the suburban planning area, PA-2. Preservation of farmland is a key environmental objective of the State Plan which has set a target of preserving 550,993 acres of farmland statewide by 2010. State investment to preserve farmland in the suburban and the environmentally sensitive rural planning areas of the Township is already underway with farms either under contract to be purchased or having been purchased by the State program. Currently, eleven farms in Manalapan have applied to be preserved under the State and County easement purchase programs for farmland preservation. In addition to easement purchases, the County Plan encourages the use of innovative techniques such as Farmland Preservation Subdivisions similar to the one adopted in Upper Freehold Township.

RECOMMENDATIONS

The number of farms and the amount of farmland in Manalapan Township are in jeopardy from continued development pressures. The Township should undertake the following measures to support State and County farmland preservation efforts and protect the public investment in farmland preservation:

- The Township should pursue further density reductions in agriculturally significant areas to reduce the development pressures on Township farm areas and the potential conflicts that result from the introduction of non-farm uses.

- The Township, in cooperation with the Monmouth Agriculture Development Board, should market the farmland preservation program to local farmers. Information, assistance, and support should be provided to farmers who are interested in making application for preservation funding.
 - The Township should aggressively pursue a program to preserve farmland and work with the local farmers and the Monmouth County Agriculture Development Board to promote agriculture as a business.
 - The Township should conserve open space, farms, and rural areas by limiting the extension of growth inducing infrastructure, particularly sewers.
 - The Township should preserve as much farmland as possible over the next five to ten years by leveraging monies made available through the Garden State Preservation Trust Act through a variety of mechanisms, including option agreements, installment purchases, and encouraging donations of permanent development easements.
 - The current two-cent levy approved by the Manalapan voters in 1999 permits the open space revenues to be used for farmland preservation. The Township should consider providing up to 50% of the County's share of the cost of easement acquisition in order to increase the standing of Township farms for preservation under the County program. If needed, the Township should seek voter approval for an additional dedication of local revenue to support farmland preservation.
 - The Township should apply for a Planning Incentive Grant (PIG) for Farmland Preservation Funding for Manalapan Township. The PIG program will provide up to \$1.5 million dollars annually in State grants from the State Farmland Preservation Trust to preserve Township farms. To secure additional County funding to supplement State funds for farmland preservation in Manalapan, the Township should make application to the State for PIG funds through the Monmouth County Agriculture Development Board.

- To accelerate the preservation of Manalapan farms, the Township should consider undertaking advance purchases to preserve farms and seeking County and State reimbursement of Township expenditures. The Township should consider a bond issue to expedite such purchases.
 - The Township should establish a permanent Agriculture Advisory Committee to advise the Township on farmland preservation planning issues and programs and to review and make recommendations on the provisions of the Township code that affect the local farm community.

FARMLAND INVENTORY

The inventory of qualified farmland and mapping compiled by the Township provide a baseline of information for implementing the Township farmland preservation plan and are included with this element.

As of June 2001, the Monmouth County Agriculture Development Board, and/or the State of New Jersey Agriculture Development Committee, had received eleven (11) applications to preserve approximately 900 acres of farmland in Manalapan. Properties that have applied or are under contract to be preserved by the farmland preservation program are shown in Exhibit 2. One application had been withdrawn accounting for a reduction in sixty-three (63) acres. The status of the applications is summarized on Exhibit 3 and Exhibit 4.

The preservation program has, to date, successfully consummated easement purchases for two applications accounting for approximately 72 acres. 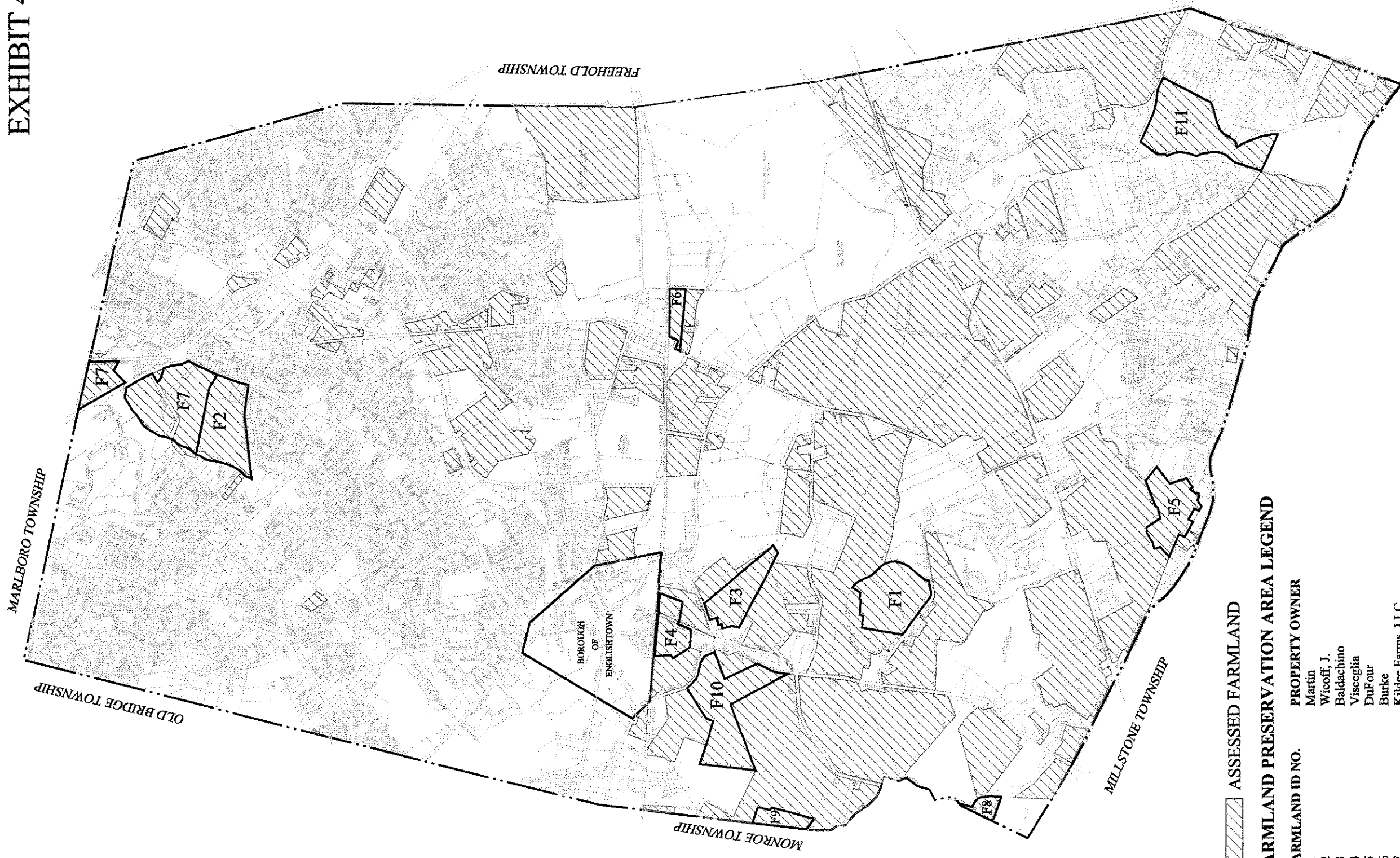
